Complete Terms and Conditions - TV Advertising This TV advertising agreement (the "Agreement") is made between My Local Lineup (the "Publisher") and the undersigned advertiser (the "Advertiser"). In consideration of the mutual promises and covenants contained in this Agreement, the parties hereto agree as follows:  
 1. **Advertising** Publisher shall use its diligent efforts to provide advertising services specified in Agreement. Any advertising submitted by Advertiser must be in form and substance acceptable to Publisher. Publisher reserves the right to refuse any ad for any and all reasons.  
 2. **Payments.** (a) Advertiser shall pay annually the total amount set forth in Agreement to Publisher. Each year, Advertiser shall pay that amount as specified in agreement: either in full or in installments. If in full, the total annual amount of the TV Advertising Agreement is due by the 15th of the month preceding the first scheduled advertisement. If in installments, the total advertising fee for the immediately approaching month is due by the 15th of the month preceding it. (b) The advertising fees do not include commercial production. A fully produced commercial and other requested artwork received after artwork deadline will incur a 10% late fee for that month's advertising fees. Artwork deadline is on the 15th of the month preceding the date when commercial is scheduled to air. (c) Payments received after 10 days from due date will incur in a 5% late fee plus 2%/mo interest until payment has been received in full. (d) My Local Lineup reserves the right to stop advertisement campaign, in part or in its totality, if previous monthly payments are overdue. 3. **Indemnity.** Advertiser shall at all times defend, indemnify, and hold harmless Publisher and its officers, directors, shareholders, employees, accountants, attorneys, agents, affiliates, subsidiaries, successors, and assigns from and against any and all damages, lawsuits & losses arising from Advertiser's published advertisements. 4. **Changes.** If Advertiser wishes to make changes to Agreement, including cancellation, requests must be sent via email to info@mylocallineup.com. Publisher reserves the right to change publication schedule and deadlines. 5. **Limitation of Liability.** (a) Under no circumstances shall publisher and any of its members be liable to advertiser or any third party for indirect, incidental, consequential, special, or exemplary damages (even if advised of the possibility of such damages), arising from this agreement. (b) Publisher and its members disclaim any and all representations and warranties, including any regarding merchantability, fitness for particular purposes, suitability, compliance with laws, quality, or otherwise, with respect to the Publisher's products. (c) In no event shall publisher and its members be liable in any way for an amount greater than the payment owed to Publisher under this agreement. (d) Publisher and its members would not have entered into this Agreement but for the limitations contained in this section. 5. **Counterparts and Facsimile Signatures.** This Agreement may be executed in multiple counterparts, each of which shall be deemed to be an original, but all of which together shall constitute a single instrument.
